### How It All Started

Founded in 1975 and based in Hope Hull, Alabama, VT Miltope is the leading manufacturer of computers, servers/storage, network peripherals, and airborne solutions geared toward top performance under the most demanding environmental conditions.

VT Miltope is part of Singapore Technologies Engineering Ltd – an integrated defense and engineering group specializing in the aerospace, electronics, land systems and marine sectors. Singapore Technologies Engineering has global presence in Asia, the Americas, Europe and the Middle East and employs about 22,000 employees.

VT Miltope's account reconciliation process was tedious and not well organized due to the manual nature of the work. During month-end close, accountants expend extra energy in their close and reconciliations, which were mainly caused by:

- Unclear statuses of reconciliations
- Challenges in adhering to deadlines
- Inconsistent approach to doing reconciliations

- Wasted time due to manual activities such as scanning, copying and pasting Excel coversheets

VT Miltope's goal was to find a solution that could provide more precision and accuracy to the balance sheet account reconciliation process by producing standardized, higher quality reconciliations and real-time automatic management of all reconciliations.
